- NEW REQUIREMENT: Viability, Capability, Accountability (Pre-Application Process for Non-Profit Organizations)
- Submitted once
- Updated Annually



# WHAT'S NEW IN 2016?

---

## Application Addendum

- Located on webpage under Application
- Must complete and attach to e-mail to SA
- Serves as notification to SA that entire application is complete



# What is **not** new in 2016?

---

## Application

- Single Sign-on Login
- Summer Food Program
- Complete Application as in Prior year



# ON-LINE TRAINING FACTS

---

## Eligible Sponsors:

- Two Years' Experience as SFSP Sponsor
- Not Seriously Deficient



# ON-LINE TRAINING FACTS

---

## HOW TO REGISTER FOR ON-LINE TRAINING:

- ❖ Submit e-mail to State Agency requesting on-line training
- ❖ Include in e-mail:
  - Names of persons participating in training for your organization
  - Positions of persons participating
  - Phone number and preferred e-mail address for each
